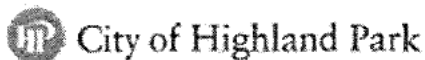

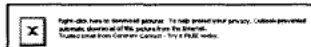

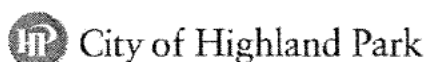

Hope you are well during this difficult time as our State grieves with the Highland Park community. Reaching out to share a few updates from ISP regarding the Highland Park shooting earlier this week. Please let me know if there is **anything** we can be helpful with.

Gubernatorial Disaster Proclamation signed on July 5, 2022:

In addition, the Governor will be ordering all persons or entities governed by the Illinois Flag Display Act to lower flags from July 5, 2022 to July 9, 2022, in honor of the lives lost in Highland Park. This will be released later today.

PUBLIC DETAILS FROM ISP

In September 2019, ISP received a Clear and Present Danger report on the subject from the Highland Park Police Department. The report was related to threats the subject made against his family. There were no arrests made in the September 2019 incident and no one, including family, was willing to move forward on a complaint nor did they

subsequently provide information on threats or mental health that would have allowed law enforcement to take additional action. Additionally, no Firearms Restraining Order was filed, nor any order of protection.

At that time of the September 2019 incident, the subject did not have a FOID card to revoke or a pending FOID application to deny. Once this determination was made, Illinois State Police involvement with the matter was concluded.

Then, in December of 2019, at the age of 19, the individual applied for a FOID card. The subject was under 21 and the application was sponsored by the subject's father. Therefore, at the time of FOID application review in January of 2020, there was insufficient basis to establish a clear and present danger and deny the FOID application.

In our continued investigation into the shooting in Highland Park on July 4, 2022, the Illinois State Police (ISP) looked into the criminal background of the individual charged in the crime.

The individual passed four background checks when purchasing firearms, through the Firearms Transaction Inquiry Program (FTIP), which includes the federal National Instant Criminal Background Check System (NICS):

- June 9, 2020
- July 18, 2020
- July 31, 2020
- September 20, 2021

The only offense included in the individual's criminal history was an ordinance violation in January 2016 for possession of tobacco.

ISP has no mental health prohibitor reports submitted by healthcare facilities or personnel.

The September 2019 Clear and Present Danger report made by the Highland Park Police Department was made in response to threats allegedly directed at the family, but the report indicates when police went to the home and asked the individual if he felt like harming himself or others, he responded no. Additionally and importantly, the father claimed the knives were his and they were being stored in the individual's closet for safekeeping. Based upon that information, the Highland Park Police returned the knives to the father later that afternoon.

ISP will continue to provide as much information as possible in an effort to be fully transparent.

GOVERNOR'S STATEMENT

Unfortunately, every time a mass shooting occurs it serves as a stark reminder that our gun laws often fall short of the rigorous standards that feel like common sense to most Americans. I call on all Illinoisans to learn about and use the Illinois Firearm Restraining Order Act already in law to alert authorities to dangerous individuals with guns. My administration will work with the General Assembly to ensure we take on the gun lobby and do everything we can to further strengthen our gun control and red flag laws. While I support an assault weapon and high capacity magazine ban at the state level, we urgently need federal regulation on the weapons of war and high capacity magazines that are used only for mass murder. Illinois is not an island, and even with the some of the strictest gun laws in the nation, our state is only as safe as the state with the weakest laws—many of which border Illinois.

Again, please let me know if we can be helpful with anything. Sending my best during this time. Thank you.

Hope you are well during this difficult time as our State grieves with the Highland Park community. Reaching out to share a few updates from ISP regarding the Highland Park shooting earlier this week. Please let me know if there is **anything** we can be helpful with.

Gubernatorial Disaster Proclamation signed on July 5, 2022:

In addition, the Governor will be ordering all persons or entities governed by the Illinois Flag Display Act to lower flags from July 5, 2022 to July 9, 2022, in honor of the lives lost in Highland Park. This will be released later today.

PUBLIC DETAILS FROM ISP

In September 2019, ISP received a Clear and Present Danger report on the subject from the Highland Park Police Department. The report was related to threats the subject made against his family. There were no arrests made in the September 2019 incident and no one, including family, was willing to move forward on a complaint nor did they

subsequently provide information on threats or mental health that would have allowed law enforcement to take additional action. Additionally, no Firearms Restraining Order was filed, nor any order of protection.

At that time of the September 2019 incident, the subject did not have a FOID card to revoke or a pending FOID application to deny. Once this determination was made, Illinois State Police involvement with the matter was concluded.

Then, in December of 2019, at the age of 19, the individual applied for a FOID card. The subject was under 21 and the application was sponsored by the subject's father. Therefore, at the time of FOID application review in January of 2020, there was insufficient basis to establish a clear and present danger and deny the FOID application.

In our continued investigation into the shooting in Highland Park on July 4, 2022, the Illinois State Police (ISP) looked into the criminal background of the individual charged in the crime.

The individual passed four background checks when purchasing firearms, through the Firearms Transaction Inquiry Program (FTIP), which includes the federal National Instant Criminal Background Check System (NICS):

- June 9, 2020
- July 18, 2020
- July 31, 2020
- September 20, 2021

The only offense included in the individual's criminal history was an ordinance violation in January 2016 for possession of tobacco.

ISP has no mental health prohibitor reports submitted by healthcare facilities or personnel.

The September 2019 Clear and Present Danger report made by the Highland Park Police Department was made in response to threats allegedly directed at the family, but the report indicates when police went to the home and asked the individual if he felt like harming himself or others, he responded no. Additionally and importantly, the father claimed the knives were his and they were being stored in the individual's closet for safekeeping. Based upon that information, the Highland Park Police returned the knives to the father later that afternoon.

ISP will continue to provide as much information as possible in an effort to be fully transparent.

GOVERNOR'S STATEMENT

Unfortunately, every time a mass shooting occurs it serves as a stark reminder that our gun laws often fall short of the rigorous standards that feel like common sense to most Americans. I call on all Illinoisans to learn about and use the Illinois Firearm Restraining Order Act already in law to alert authorities to dangerous individuals with guns. My administration will work with the General Assembly to ensure we take on the gun lobby and do everything we can to further strengthen our gun control and red flag laws. I hope you and everyone working for the city are doing well and healing as best you can from yesterday.

The efforts of everyone in Highland Park, from you and the mayor, the first responders, the medical team at HP Hospital and the countless others who rushed to help those in need have all been incredible and demonstrate why Highland Park is such a special place. Although the innocence and happiness that is Highland Park was shattered by the deafening sound of automatic fire yesterday, our community is strong and I know we'll all get thru this.

During the parade yesterday, I was sitting with my family on Central, about 30 or 40 feet west of Second Street. Fortunately, my family escaped without harm, for which we are grateful.

In the chaos, like everyone around us, we evacuated the area leaving many of our personal items behind. My inquiry is minuscule in comparison to all of the efforts the city continues to deal with, but I wanted to reach out to inquire if there are any plans regarding retrieving the personal items left behind on Central. The items we left were mostly objects that are easily replaced, but we did have one item with us that has a personal importance to my family and if we can retrieve the item at some point, it would provide some needed resolve to a day that will be with us for the rest of our lives.

I of course understand the authorities are focused on their investigation and the last thing my family wants to do is impede the investigation in any way. I am simply reaching out to see if there is a plan or thought when or if we may have the opportunity to retrieve items left behind, if they are even still there?

Lastly, if there is anything I can do to be of assistance, please don't hesitate to ask. Highland Park is my home and if there is anything I can do to be of assistance, please let me know.

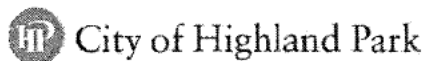

Hello , my name is Jeff Neimark . I am a retired Lieutenant with the Highwood Police Department from 1989 to 2007 . I also recently retired as the Town Marshal in Hanna Wyoming in June 2021. I had served over a decade as the Town Marshal . Please google my name and you will see some of my accomplishments during my career. I had also received commendation letters from Wyoming Senator John Barrasso relating to my dedication and service to the community and state. I have also served as an active member of the International Association of Chiefs of Police. I have a total of 31 years of Police experience .

I felt it necessary to write to you because of the misinformation being given out by the Deputy Chief of the Lake County Sheriffs Office . He is the spokesman for the major crimes task force.

During one of his press briefings he had given out information that is just false and not true. I could not just sit and not respond to someone who appears does not want to tell the truth about what the Highland Park Police Department should and could have done relating to the incidents of Crimo making statements about killing his family. The spokesman also made false statements about what Law Enforcement could not do in these type of situations . It is misleading the public and it is wrong.

Deputy Chief Covelli had told new agencies , the public, victims and other Law Enforcement personnel that when Highland Park Officers responded to the threat call relating to Crimo threatening to kill his family that essentially nothing could be done because officers cannot detain anyone or take law enforcement action , including arresting someone because they did not have probable cause. Deputy Chief Covelli further stated law Enforcement could not take any further action because the family did not want to sign complaints . This statement is patently false and is ignorant to the law. Why would the Deputy Chief make such a false assertion to everyone listening.

Deputy Covelli had further stated that Law Enforcement -Police Officers could not detain anyone unless they had Probable Cause. The fact is a Police Officer can detain anyone based on Reasonable Suspicion not Probable Cause . Probable Cause is a higher standard and is required to make an arrest. Probable Cause which is a higher standard is not required to detain someone, only reasonable suspicion is required which is a lower threshold.

This is very important and the truth needs to be stated and corrected from what the Deputy Chief had indicated in the press conference. The family does not have the ultimate say in deciding the action of law enforcement in this incident. The family is not allowed to say they will not sign

complaints when a family member threatens to kill the entire family. This is the same in Domestic Abuse Situation . This is due to several reasons such as coercion and the violent behavior of a suspect .

Law Enforcement has the absolute right to detain someone who has threatened suicide and in another incident a week later to kill their entire family, a police officer is required to detain this person for investigation. To say otherwise is completely false and is misleading the public. Why the Highland Park Police Chief would not correct the record is beyond me.

This is very important again to note. A police officer is required to detain someone for further investigation if they threaten to kill their entire family. The Deputy Chief makes no mention of this. The Deputy Chief again had stated the Police Officers needed probable cause to detain someone and have signed complaints by family members. This is not true and is false and misleading.

The Highland Park Police Officers had an absolute obligation not only to detain Crimo but to take him in to be evaluated by a Medical Examiner for a mental evaluation. This is very common and routine . Police Officers are required to take action if there is a threat to harm and kill anyone, especially if they had made statements to kill themselves previously and there where reports of 15 knives and other weapons in the possession of Crimo. Highland Park Police Department had this information of his mental instability in the past and chose not to take action other then give the knives to his Uncle or another family member for safe keeping . Apparently according to the Deputy Chief Highland Park Police later gave this information to the State Police . This does not negate the action the Highland Police Department should have taken in this situation . I would be interested to know if the Highland Park Police followed up with the State Police on Crimo and what the outcome was.

If Mr. Crimo was taken into custody for a mental evaluation that day, it is very possible he would have been admitted to a mental facility he would have been flagged from never being able to get a FOID Card to purchase or possess any weapons.

Also I would like to know who signed off on his FOID card application with the State Police . Who else may have signed off on his application or had never flagged it from the Highland Park Police Department. This needs to be investigated .

Police officers are not trained to medically evaluate people in these situations . Crimo not only needed to be detained but also placed in custody and taken to the hospital for a mental evaluation . There was substantial evidence based on the statements by Crimo to do this.

Furthermore, this was a crime. The fact that Crimo threatened to kill his family is a crime. Why was this not treated as such. The police report at a minimum should have been sent to the Lake County Attorneys Office for review and criminal charges in this case should have been brought. Why did this not occur. This needs to be asked and investigated. If the Lake County Attorney did not charge or follow up with the Highland Park Police Department . Someone needs to ask why? I will be seeking answers myself and will be contacting the Lake County Attorneys Office as well as reporting this information to Highland Park Mayor and City Council for answers .

I have detained well over 150 people in my career and placed them in custody for a Medical Evaluation by a physician. Many of these situation included a lot less evidence then what the Highland Park Police Department had reportedly with Crimo. This has been done with Reasonable Suspicion that included people wanting to harm themselves and others. To say there

was no reasonable suspicion or even probable cause to take Crimo in for a Mental Evaluation is ridiculous and is also disturbing on many levels.

I am also a Highland Park native , growing up in Highland Park. I am very concerned of the actions of the Highland Park Police in this case along with statements by the Deputy Chief that are very peculiar in nature as a law enforcement officer . The public deserves answers. Thank you .

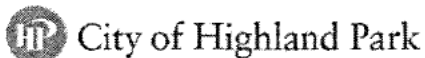

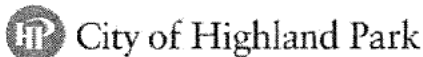

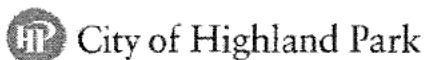

First, thank you for handling everything so well today. It must have been horribly wrenching, but you had us all well taken care of.

If you or others at the Village of Glencoe are reaching out to Highland Park, could you please remind them that Paws for Patrick is here for them?

In fact, therapy dogs were shipped to Uvalde, TX after the school shooting and we're fortunate to have dozens of therapy dogs within miles of Highland Park ready to help those who need it. We've also found people have contacted us about getting an emotional support animal within hours of experiencing their own unthinkable tragedy and we're here for that, too, and want people to know that.

Highland Park has been a great supporter of Paws for Patrick and we have a strong relationship, but the circumstances may challenge making the connection that can make a difference. I'm told City Manager Ghida Neukirch is who we should talk to, but I haven't yet found a way of making contact that I think will be heard through the noise. Maybe there's someone else we should contact - not sure.

Either way, we know therapy dogs and emotional support animals can make a critical difference in this sort of situation sooner than some think, and we want to do whatever we can to let that happen. Any thoughts you may have or contacts that can get us closer to helping are much appreciated.

Hello , my name is Jeff Neimark . I am a retired Lieutenant with the Highwood Police Department from 1989 to 2007 . I also recently retired as the Town Marshal in Hanna Wyoming in June 2021. I had served over a decade as the Town Marshal . Please google my name and you will see some of my accomplishments during my career. I had also received commendation letters from Wyoming Senator John Barrasso relating to my dedication and service to the community and state. I have also served as an active member of the International Association of Chiefs of Police. I have a total of 31 years of Police experience .

I felt it necessary to write to you because of the misinformation being given out by the Deputy Chief of the Lake County Sheriffs Office . He is the spokesman for the major crimes task force.

During one of his press briefings he had given out information that is just false and not true. I could not just sit and not respond to someone who appears does not want to tell the truth about what the Highland Park Police Department should and could have done relating to the incidents of Crimo making statements about killing his family. The spokesman also made false statements about what Law Enforcement could not do in these type of situations . It is misleading the public and it is wrong.

Deputy Chief Covelli had told new agencies , the public, victims and other Law Enforcement personnel that when Highland Park Officers responded to the threat call relating to Crimo threatening to kill his family that essentially nothing could be done because officers cannot detain anyone or take law enforcement action , including arresting someone because they did not have probable cause. Deputy Chief Covelli further stated law Enforcement could not take any further action because the family did not want to sign complaints . This statement is patently false and is ignorant to the law. Why would the Deputy Chief make such a false assertion to everyone listening.

Deputy Covelli had further stated that Law Enforcement -Police Officers could not detain anyone unless they had Probable Cause. The fact is a Police Officer can detain anyone based on Reasonable Suspicion not Probable Cause . Probable Cause is a higher standard and is required to make an arrest. Probable Cause which is a higher standard is not required to detain someone, only reasonable suspicion is required which is a lower threshold.

This is very important and the truth needs to be stated and corrected from what the Deputy Chief had indicated in the press conference. The family does not have the ultimate say in deciding the action of law enforcement in

this incident. The family is not allowed to say they will not sign complaints when a family member threatens to kill the entire family. This is the same in Domestic Abuse Situation . This is due to several reasons such as coercion and the violent behavior of a suspect .

Law Enforcement has the absolute right to detain someone who has threatened suicide and in another incident a week later to kill their entire family, a police officer is required to detain this person for investigation. To say otherwise is completely false and is misleading the public. Why the Highland Park Police Chief would not correct the record is beyond me.

This is very important again to note. A police officer is required to detain someone for further investigation if they threaten to kill their entire family. The Deputy Chief makes no mention of this. The Deputy Chief again had stated the Police Officers needed probable cause to detain someone and have signed complaints by family members. This is not true and is false and misleading.

The Highland Park Police Officers had an absolute obligation not only to detain Crimo but to take him in to be evaluated by a Medical Examiner for a mental evaluation. This is very common and routine . Police Officers are required to take action if there is a threat to harm and kill anyone, especially if they had made statements to kill themselves previously and there where reports of 15 knives and other weapons in the possession of Crimo. Highland Park Police Department had this information of his mental instability in the past and chose not to take action other then give the knives to his Uncle or another family member for safe keeping . Apparently according to the Deputy Chief Highland Park Police later gave this information to the State Police . This does not negate the action the Highland Police Department should have taken in this situation . I would be interested to know if the Highland Park Police followed up with the State Police on Crimo and what the outcome was.

If Mr. Crimo was taken into custody for a mental evaluation that day, it is very possible he would have been admitted to a mental facility he would have been flagged from never being able to get a FOID Card to purchase or possess any weapons.

Also I would like to know who signed off on his FOID card application with the State Police . Who else may have signed off on his application or had never flagged it from the Highland Park Police Department. This needs to be investigated .

Police officers are not trained to medically evaluate people in these situations . Crimo not only needed to be detained but also placed in custody and taken to the hospital for a mental evaluation . There was substantial evidence based on the statements by Crimo to do this.

Furthermore, this was a crime. The fact that Crimo threatened to kill his family is a crime. Why was this not treated as such. The police report at a minimum should have been sent to the Lake County Attorneys Office for review and criminal charges in this case should have been brought. Why did this not occur. This needs to be

asked and investigated. If the Lake County Attorney did not charge or follow up with the Highland Park Police Department . Someone needs to ask why? I will be seeking answers myself and will be contacting the Lake County Attorneys Office as well as reporting this information to Highland Park Mayor and City Council for answers .

I have detained well over 150 people in my career and placed them in custody for a Medical Evaluation by a physician. Many of these situation included a lot less evidence then what the Highland Park Police Department had reportedly with Crimo. This has been done with Reasonable Suspicion that included people wanting to harm themselves and others. To say there was no reasonable suspicion or even probable cause to take Crimo in for a Mental Evaluation is ridiculous and is also disturbing on many levels.

I am also a Highland Park native , growing up in Highland Park. I am very concerned of the actions of the Highland Park Police in this case along with statements by the

Deputy Chief that are very peculiar in nature as a law enforcement officer . The public deserves answers. Thank you .

How the idea of privacy has changed in the US

The Constitution includes 4,400 words, and not one of them is the word "privacy." In an effort to contextualize the changes in American thinking about privacy in the digital age, Stacker investigated the way the idea of privacy has changed in the U.S. during the last two decades using a variety of news and government sources.

The concept of privacy has been part of the American consciousness since the first steps of the colonial revolution. When the inhabitants of the 13 colonies first began organizing, they needed a way to communicate outside of the watchful eye of the British Royal Post. As a result, they began what would eventually be the foundation of the U.S. Postal Service on the principle that no mail carrier had the right to read the letters being sent, unlike the British Post.

Since the 1700s, privacy in the U.S. has been a hotly debated issue. Depending on the specific decision, excerpts of the First, Third, Fourth, Fifth, Ninth, and 14th amendments of the Constitution have been used to justify various levels and types of privacy. Beyond the Constitution, a variety of privacy legislation has been passed at the federal level, protecting specific types of personal information and activities.

"[American privacy legislation] does tend to be very sectoral," said Hayley Tsukayama, the senior legislative activist for the Electronic Frontier Foundation. "[Legislators] are still really looking at data weaponization. When there's an incident, they're willing to react legislatively, but it's very difficult to get them to react [with protections] for all data."

When examining federal privacy legislation, Tsukayama's point about sectoral regulation becomes apparent. Six laws explicitly protect various privacy rights, covering financial information collected by credit agencies, personal information collected by the government, data collected during the act of a computer software hack, information collected online from children under 13 years old, the disclosure of information sold by financial institutions, and health information possessed by a health care provider.

Each of these laws not only specifies a narrow type of data that must remain private, but also only protects that data when it's possessed by a particular person or organization.

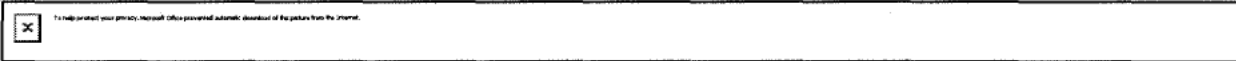
