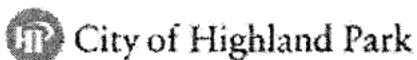

Chris:

Here is the quote for the replacement to the Pratt Positron actuator. I don't know the torque of the existing Pratt but I was looking at the torque chart for this 18" Pratt butterfly valve. At 80-90 PSI the torque requirement is around 800 lb.ft. I quoted our 1000 lb.ft. model to have a little headroom. For this size Pratt valve we don't have any hardware currently in stock. Our standard leadtime would be 10 weeks. I will have to initiate a schedule request if you want me to try for something sooner. We would most probably have an adder of \$500-1000 to turn something in a quicker timeframe. Let me know.

Dear Members,

On behalf of the Senior Center staff, we are devastated and heart-broken over the senseless act of violence against our community, that occurred during today's 4<sup>th</sup> of July parade. Our hearts go out to those who lost their lives and those who were injured - and to their families and loved ones as well.

After thoughtful consideration, we have decided that the Senior Center will be open tomorrow, and that all classes and activities will be held as scheduled. We hope this decision will allow us to grieve together and just maybe we can begin to heal together as well.

As a life-long resident of Highland Park who lives and works in this beloved community – the pain is palpable – and we are experiencing this pain together. The outpouring of love and support our community has shown – is one of the reasons I love Highland Park. Together, we will get through this.

If you are seeking support after today's tragic events, you are invited to participate in a coordinated effort to provide crisis counseling to anyone in need. The City of Highland Park, District 112, District 113, and the Park District will have counselors available for community members in need of support. Counseling will be available at the Highland Park High School, 433 Vine Avenue tomorrow (Tuesday) from 9:00 AM to 2:00 PM; please enter through the Vine Avenue entrance. Anyone who wishes to take advantage of counseling services, will need to present a valid driver's license or student ID to be cleared to enter the school; no appointments are necessary.

### **Message from Mayor Rotering**

Today was the bloodiest day that we have ever experienced in Highland Park. This morning at approximately 10:14 AM a shooter opened fire with an assault weapon on a crowd attending our 4th of July parade. We know at this time that six individuals lost their lives and at least 24 were injured. Our hearts go out to the victims, families, and our community.

The attack prompted an immediate and well-coordinated response from multiple law enforcement agencies at the Federal, State, County, and local levels. A suspect, Robert "Bobby" Crimo III (age 22 of Highwood, Ill.) was identified and a massive manhunt ensued.

At approximately 6:30 p.m., the suspect was apprehended on Route 41 at Westleigh Road. He was taken into custody without incident and is currently being processed through the Highland Park Police Department.

Throughout the day we have received offers of support and resources from public officials and agencies including President Biden. Fellow mayors have reached out from across the country, many who lead communities that have experienced this pain and tragedy. We thank Governor J.B. Pritzker, Senator Richard Durbin, Senator Tammy Duckworth, Congressman Brad Schneider, Illinois State Senator Julie Morrison, and Illinois State Representative Bob Morgan for coming to support our community and for providing every available resource.

I want to thank our first responders for their bravery and extraordinary efforts today. Our police and firefighters saved countless lives with their responses -- running into danger and taking immediate action to save others. We are grateful for these selfless acts. We know there were members of our community who rendered aid and assistance as well, and we thank each and every one of you for those efforts.

I also want to acknowledge and thank numerous agencies for their support including American Red Cross, World Central Kitchen, Lakeshore Country Club, Northmoor Country Club, Soul and Smoke food truck, Catering by Michaels, Northern Illinois Critical Incident Stress Management, local clergy and many other individuals and agencies have stepped up to provide food and support for our first responders. We are grateful for their generosity.

Our community, like so many before us, is devastated. It's impossible to imagine the pain of this kind of tragedy until it happens in your backyard. Gun violence - a mass shooting such as this casts a much wider net of agony than what the public is typically exposed to; it's a crisis that devastates entire families and communities in a single moment and we know will take time to heal.

Tomorrow the President will order our flags to fly at half-mast, and many public programs have been canceled. Please check with your camps and activities to see if they are operating. In the days and weeks ahead we will come together as a community to mourn and begin the path of healing. I will share more information as it is available.

### **Road and Business Closures**

Numerous roads will remain closed in central downtown Highland Park for the FBI investigation, and many businesses will remain closed. The area closure spans Laurel Avenue from First Street to Elm Place and Green Bay Road from First Street to Elm Place (map below). Detours will be established, but please limit your travel only to essential business in Highland Park. The City is reaching out to business owners to share information, and will work with them to reopen as soon as possible.

### **Counseling Resources**

A coordinated effort is also being made to provide crisis counseling to anyone in need. The City of Highland Park, District 112, District 113, and the Park District will have counselors available at Highland Park High School, 433 Vine Ave., for community members in need of assistance, tomorrow from 9:00 AM to 2:00 PM. No appointment is necessary. The Vine Ave. entrance will be open and anyone who wishes to take advantage of counseling services will need to have a valid driver's license or student ID to be cleared to enter the school.

The theme of this year's parade was community -- and while we are hurting -- we know that we will come together and support each other, as we always do, in difficult times. We are Highland Park strong.

#### **Meal Trains**

When organizing meal trains for victims and/or family members, **it is important to keep addresses private and off the Internet for public consumption for the sake of the victim bases' safety.** In Parkland, we found multiple times that people would sign up to "help" for meal trains with an ulterior motive to gain the victims' families and survivors' addresses for their own personal gain. To avoid this, we had multiple volunteers set up on a nightly basis to truly help on the meal train. We had a volunteer pick up from the restaurant, then hand the food off to another person Authorized by the families to have the home address and deliver the food to the location. This maintains privacy.

## **FIREARMS RESTRAINING ORDER**

*EMPOWERING LAW ENFORCEMENT AND  
FAMILIES TO PREVENT GUN VIOLENCE*

**WHAT IS A FIREARMS RESTRAINING ORDER?** On January 1, 2019, the Firearms Restraining Order Act (430 ILCS 67/1) went into effect in Illinois. The Firearms Restraining Order Act provides a formal legal process to ask a court to issue a Firearms Restraining Order (or “FRO”) to temporarily limit an individual’s access to firearms, ammunition, and firearm parts when that person poses a significant danger to themselves or others. A Firearms Restraining Order is a civil court order that temporarily prohibits a person from possessing or buying firearms, ammunition, and firearm parts that could be assembled to make an operable firearm.

**WHEN IS FIREARMS RESTRAINING ORDER NEEDED?** The purpose of the Firearms Restraining Order Act is to prevent individuals who pose an elevated risk of endangering themselves or others from accessing firearms, ammunition, and firearm parts before they harm themselves or others. Before many shootings, family members of the shooter have observed dangerous behaviors or have grown concerned about their risk of harming themselves or others. Family and household members are often the first to know when someone is in crisis or poses a harm. In addition, law enforcement officers frequently come in contact with individuals who are dangerous or in crisis. The Firearms Restraining Order Act allows a family or household member and law enforcement officers to ask a court to restrict a person’s access to firearms, ammunition, and firearm parts to prevent the commission of gun violence.

**HOW LONG DOES A FIREARMS RESTRAINING ORDER LAST?** There are two types of FROs: an emergency FRO that immediately addresses a crisis and lasts up to 14 days, and a six-month FRO that provides longer protection but only after there has been a full court hearing.

**HOW DOES A FIREARMS RESTRAINING ORDER WORK?** A family member (including an ex-spouse and a person with a child in common with the respondent) or household member or law enforcement can petition an Illinois circuit court for an order to temporarily limit the access to firearms, ammunition and firearms parts of a named “respondent”—the individual who poses a danger of injury. Based on the evidence in the petition, a judge may issue an emergency FRO immediately that will be in place for 14 days. The judge then will hold a full hearing to decide whether to end the emergency FRO or whether to issue a longer, six-month FRO.

A petition for a firearm restraining order may be filed in any county where the respondent resides or any county where an incident occurred that involved the respondent posing an immediate and present danger of causing personal injury to the respondent or another by having in his or her custody or control or purchasing, possessing or receiving a firearm, ammunition, or firearm parts that could be assembled to make an operable firearm.

There are two stages in the process for obtaining an FRO:

**Stage 1:** Law enforcement or family/household member fills out a petition explaining how the respondent’s access to firearms poses an immediate and present danger of causing injury to themselves or others. The petition may be filed in any county where the respondent lives or in any county where an incident occurred that involved the respondent posing an immediate and present danger of causing personal injury by having in his or her custody or control, or purchasing, possessing, or receiving, a firearm, ammunition, or firearm parts that could be assembled to make an operable firearm. Generally the petitioner does not have to notify the respondent yet, but the petitioner must make an effort to notify an intimate partner of the respondent if they are a target of the respondent.



An emergency hearing is held the next day court is in session. The judge issues an emergency FRO if they find probable cause to believe the respondent poses an immediate and present danger of causing injury. If an emergency FRO is issued, a full hearing is scheduled as soon as possible so the respondent can be heard, and the full hearing must be held within 14 days. During the short period of time before a full hearing can be held, the emergency FRO ensures that the respondent is prohibited from purchasing or possessing a firearm ammunition, or firearm parts that could be assembled to make an operable firearm.

**Stage 2:** At the full hearing, the judge considers whether to end the emergency FRO or whether to extend it to a six-month FRO. At the hearing, the burden is on the petitioner to show “by clear and convincing evidence” that the respondent creates “a significant danger” of injury to themselves or others by having access to firearms. Petitioners are required to present evidence to the court, and respondents also have an opportunity to present evidence. If the court decides the respondent presents a significant danger, the court will issue an order prohibiting the respondent from the purchase and possession of firearms ammunition, or firearm parts that could be assembled to make an operable firearm for six months.

Note that family, household members, or law enforcement can choose to skip the emergency FRO process and petition directly for a six-month FRO. Further, a petitioner who obtains a 14-day FRO is not required to proceed with the six-month FRO process if the danger is no longer present.

**WHAT KINDS OF EVIDENCE DOES THE COURT NEED?** The petitioner and respondent can present any evidence they think will be relevant to the court’s decision. Examples of evidence that may help the court make a decision include, but are not limited to, facts about the respondent’s: (1) unlawful or reckless use of firearms; (2) history of physical force; (3) prior felony arrests; (4) abuse of controlled substances or alcohol; (5) recent threats or acts of violence; (6) violations of domestic violence protection orders; or (7) pattern of violence.

**CAN FROs BE TERMINATED?** Yes. The respondent is allowed one opportunity to ask the court to terminate the FRO before it expires (either before the 14-day or six-month period). In order to have the court end the FRO, the respondent must prove to the court by a “preponderance of the evidence” that he or she does not pose a danger.

**CAN FROs BE EXTENDED?** Yes. A court can renew a FRO. A petitioner may file a written request for an extension of an FRO during the final three months before the order is scheduled to expire. Before the judge will extend an FRO, the court will hold another full hearing where the petitioner again must prove by “clear and convincing evidence” that the respondent continues to pose a danger.

## HOW LONG DO FROs LAST?

There are two types of FROs: 1) an emergency FRO that immediately addresses a crisis and lasts up to 14 days, and 2) a six-month FRO that provides longer-term protection, but only after there has been a full court hearing.

## CAN FROs BE TERMINATED?

Yes. An FRO can be terminated. The respondent is allowed one opportunity to ask the court to terminate the FRO before it expires (either before the 14-day or six-month period). The respondent must prove to the court by a “preponderance of the evidence” that he or she does not pose a danger to end the FRO.

## CAN FROs BE RENEWED?

Yes. A court can renew an FRO. A petitioner may file a written request for an extension of an FRO during the final three months before the order is scheduled to expire. Before the judge will extend an FRO, the court will hold another full hearing where the petitioner again must prove by “clear and convincing evidence” that the respondent continues to pose a danger.

## HOW CAN I GET HELP WITH THIS PROCESS?

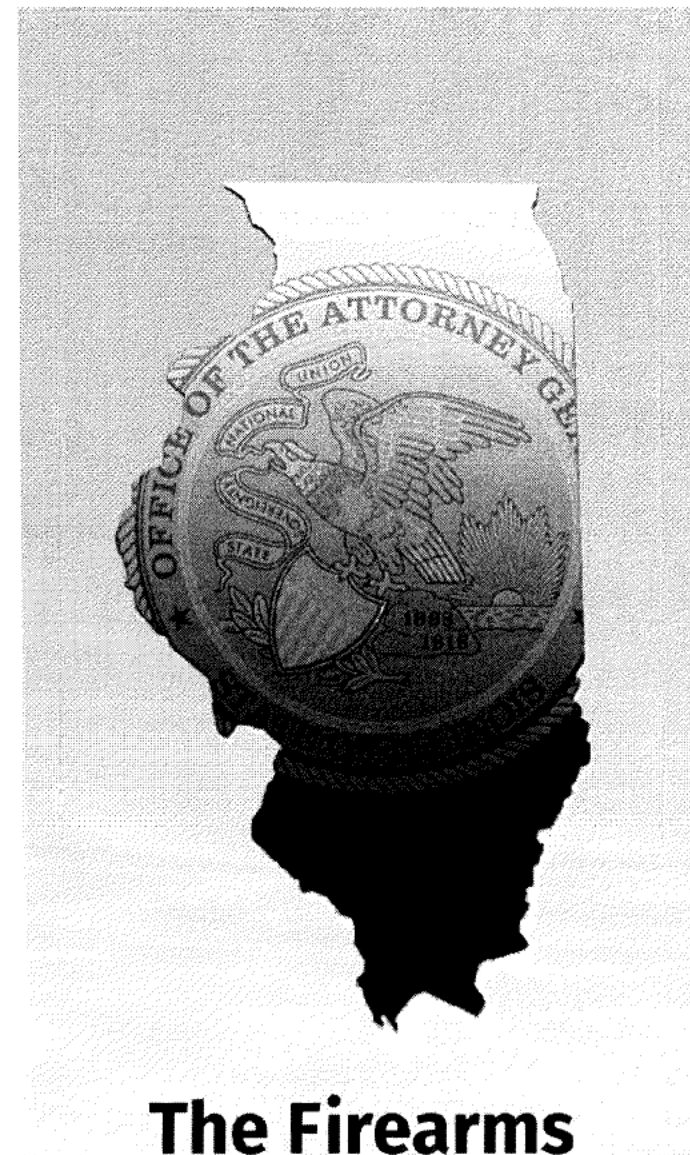
A petition for a firearm restraining order may be filed in any county where the respondent resides or any county where an incident occurred that involved the respondent posing a threat. The clerk in the court where you ask for an FRO can assist you with writing and filing a petition. Make sure also to report immediate safety threats to local law enforcement.

# **The Firearms Restraining Order**



## **WHAT IS A FIREARMS RESTRAINING ORDER?**

A Firearms Restraining Order (or “FRO”) is a civil court order that temporarily prohibits a person from possessing or buying firearms, ammunition, and firearm parts that could be assembled to make an operable firearm when that person poses an immediate danger to themselves or others. A Firearms Restraining Order is obtained through a formal legal process during which a petitioner asks a court to issue an FRO.

## **WHEN ARE FROs NEEDED?**

The purpose of a Firearms Restraining Order is to prevent individuals who pose an elevated risk of endangering themselves or others from accessing guns before they harm themselves or others. Before many shootings, family members of the shooter have observed dangerous behaviors or have grown concerned about their risk of harming themselves or others. Family and household members are often the first to know when someone is in crisis or poses a harm. A Firearms Restraining Order is a way for family or household members or law enforcement to ask a court to restrict a person’s access to guns to prevent the commission of gun violence.

## **WHO CAN PETITION FOR AN FRO?**

### ***FAMILIES & HOUSEHOLD MEMBERS:***

If you believe that a family or household member may harm themselves or others by having a firearm, petitioning for an FRO can be an important step to reduce the risk. When petitioning for an FRO, a family member is defined as: a spouse, former spouse, person with whom the respondent has a minor child in common, parent, child, step-child, any other person related by blood or marriage, or a person who shares a common dwelling. You should also immediately contact local law enforcement to report the situation.

### ***LAW ENFORCEMENT:***

Law enforcement officers can identify individuals who pose a threat of harm by having access to firearms. Obtaining an FRO can be a proactive way to prevent violence if law enforcement officers encounter someone demonstrating that they pose a risk to themselves or others.

## **HOW DOES A FIREARMS RESTRAINING ORDER WORK?**

A family or household member or law enforcement can ask, or “petition,” an Illinois circuit court for an order to temporarily limit firearm access for a “respondent,” the individual who poses a danger of injury. After an initial hearing based on evidence in the petition, a judge may issue an emergency FRO immediately. The judge then will hold a full hearing to decide whether to end the emergency FRO or whether to issue a six-month FRO. There are two stages in the process for obtaining an FRO:

***Stage 1:*** Law enforcement or a family or household member fills out a petition explaining how the respondent’s access to firearms poses an immediate and present danger of causing injury to themselves or others. The petition is then filed at the court in any county where the respondent resides. The petitioner does not have to notify the respondent about filing the petition. However, the petitioner must make an effort to notify an intimate partner of the respondent if the intimate partner is a target.

The court will hold an emergency hearing the next day it is in session. The judge will issue an emergency FRO if they find probable cause to believe the respondent poses an immediate and present danger of causing injury. If an emergency FRO is issued, a full hearing is scheduled as soon as possible so the respondent can be heard, and the full hearing must be held within 14 days. During the short period of time before a full hearing can

be held, the emergency FRO ensures that the respondent is prohibited from purchasing or possessing a firearm.

***Stage 2:*** At the full hearing, the judge considers whether to end the emergency FRO or whether to change it into a six-month FRO. At the hearing, the petitioner must show “by clear and convincing evidence” that the respondent creates “a significant danger” of injury to themselves or others by having access to firearms. A petitioner is required to present evidence to the court. A respondent also has an opportunity to present evidence. If the court decides the respondent presents a significant danger, the court issues an order prohibiting the purchase and possession of firearms for six months.

Note that a family or household member or law enforcement can skip the Emergency FRO and petition directly for a six-month FRO if they choose. Further, a petitioner who obtains a 14-day FRO is not required to proceed with the six-month FRO process if the danger is no longer present.

## **WHAT KINDS OF EVIDENCE DOES THE COURT NEED?**

The petitioner and respondent can present any evidence they think will be relevant to the court’s decision. Examples of evidence that may help the court include, but are not limited to, facts about the respondent’s:

1. unlawful or reckless use of firearms;
2. history of physical force;
3. prior felony arrests;
4. abuse of controlled substances or alcohol;
5. recent threats or acts of violence;
6. violations of domestic violence protection orders; or
7. pattern of violence.

## Message from Mayor Rotering

Today was the bloodiest day that we have ever experienced in Highland Park. This morning at approximately 10:14 AM a shooter opened fire with an assault weapon on a crowd attending our 4th of July parade. We know at this time that six individuals lost their lives and at least 24 were injured. Our hearts go out to the victims, families, and our community.

The attack prompted an immediate and well-coordinated response from multiple law enforcement agencies at the Federal, State, County, and local levels. A suspect, Robert "Bobby" Crimo III (age 22 of Highwood, Ill.) was identified and a massive manhunt ensued.

At approximately 6:30 p.m., the suspect was apprehended on Route 41 at Westleigh Road. He was taken into custody without incident and is currently being processed through the Highland Park Police Department.

Throughout the day we have received offers of support and resources from public officials and agencies including President Biden. Fellow mayors have reached out from across the country, many who lead communities that have experienced this pain and tragedy. We thank Governor J.B. Pritzker, Senator Richard Durbin, Senator Tammy Duckworth, Congressman Brad Schneider, Illinois State Senator Julie Morrison, and Illinois State Representative Bob Morgan for coming to support our community and for providing every available resource.

I want to thank our first responders for their bravery and extraordinary efforts today. Our police and firefighters saved countless lives with their responses -- running into danger and taking immediate action to save others. We are grateful for these selfless acts. We know there were members of our community who rendered aid and assistance as well, and we thank each and every one of you for those efforts.

I also want to acknowledge and thank numerous agencies for their support including American Red Cross, World Central Kitchen, Lakeshore Country Club, Northmoor Country Club, Soul and Smoke food truck, Catering by Michaels, Northern Illinois Critical Incident Stress Management, local clergy and many other individuals and agencies have stepped up to provide food and support for our first responders. We are grateful for their generosity.

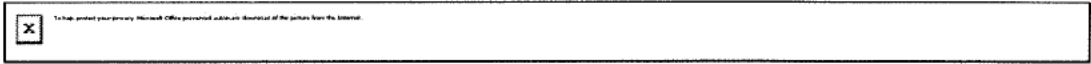
Our community, like so many before us, is devastated. It's impossible to imagine the pain of this kind of tragedy until it happens in your backyard. Gun violence - a mass shooting such as this casts a much wider net of agony than what the public is typically exposed to; it's a crisis that devastates entire families and communities in a single moment and we know will take time to heal.

Tomorrow the President will order our flags to fly at half-mast, and many public programs have been canceled. Please check with your camps and activities to see if they are operating. In the days and weeks ahead we will come together as a community to mourn and begin the path of healing. I will share more information as it is available.

### **Road and Business Closures**

Numerous roads will remain closed in central downtown Highland Park for the FBI investigation, and many businesses will remain closed. The area closure spans Laurel Avenue from First Street to Elm Place and Green Bay Road from First Street to Elm Place (map below). Detours will be established, but please limit your travel only to essential business in Highland Park. The City is

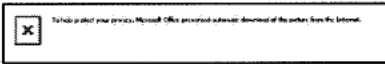

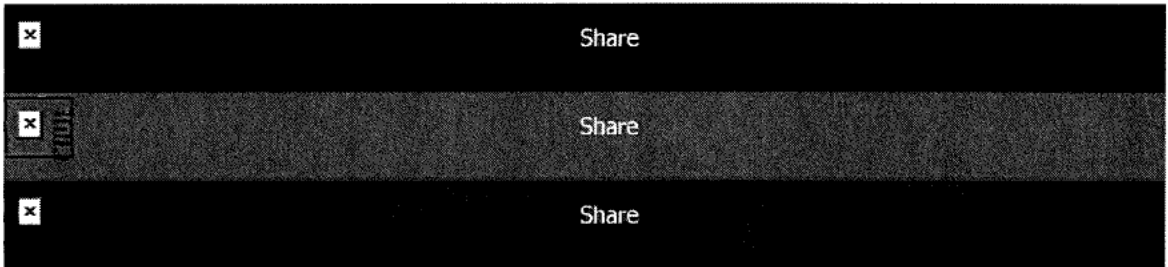
## Counseling Resources
