# Good evening Ghida:

I received the email (below in blue) from William D. Gieseke, Ph. D. who is a local psychotherapist and friend and colleague of my family. I think that I misunderstood the issue as a desire for a permanent community service center when it is a more immediate issue to provide for ongoing trauma and therapy services related to the July 4<sup>th</sup> shooting.

I am available tomorrow afternoon to discuss this.

Tony... I am involved and attached to many mental health services and initiatives. In an effort to respond to the current significant needs of the Highland Park Community after July 4th many providers are frustrated that there does not seem to be central coordination for possible providers—either now or for future and ongoing needs. Many trauma-trained organizations and providers cannot figure out with whom they should be in contact, nor do they understand how services can be shut down (high school counseling drop-in effort) so quickly. My wife is the Chair of the Illinois Childhood Trauma Coalition (The ICTC – The Illinois Childhood Trauma Coalition). She has been fielding calls and concerns about what seems to be the understandable and confusing coordination of services in Highland Park. There are particular concerns about the ongoing mental health needs of HP citizens, especially Spanish speaking. She has been relaying to me their frustrations, knowing only that I have patients in HP for whom I have been mainly concerned since the 4th.

The Clinical Director of ICTC, Dr. Cicchetti, is a valuable resource; She does and has responded to the many ongoing traumatic situations in Chicago that happen daily.
