# Mass Shootings Are Terrorism

In a sense, the mass murder at a Fourth of July parade in Highland Park, Illinois, was a symbol c how badly off-track our country has gotten. Amid the bunting and marching bands and families o lawn chairs, a disturbed idiot with a powerful rifle fired randomly at grandfathers, children and couples holding hands. Blood, bones, eyeballs and guts spilled onto the pavement alongside dropped thermoses and American flags. A 2-year-old was found, covered in blood, wandering alone. Both of his parents were dead. When his grandfather picked Aiden up at the hospital, the boy asked, "Are Mommy and Daddy coming soon?"

Mass shootings in public places are different from ordinary violence. I wish I had a dime for ever time some Republican has complained that "the media" don't pay enough attention to shootings Chicago and Detroit that happen on a regular basis. All murders are horrific of course, but the right is making a mistake if it tries to say that these mass shootings are a drop in the bucket whe compared with the overall levels of violence that plague this country, or when they object that suicides actually account for $54 \%$ of gun deaths. Those deaths are indeed horrific, which is all th
more reason to bring a sense of urgency to reducing them. It's sophistry to simply cite those statistics to wave away the epidemic of mass shootings.

Massacres at supermarkets, churches, classrooms, shopping malls and, good God, July Fourth parades are not like other violence. They shatter our sense of safety. They destroy our sense of normal life. Who among us has not wondered whether we might fall victim to this madness at a ballgame or a concert? This epidemic of mass random shootings is not like gang killings in cities It's like terrorism. It invades the normal, peaceful world - the places in which we must feel secure.

After 9/11, we went to war and spent trillions of dollars on security. Arguably, we overreacted, bl the sense of an overarching menace was powerful. It may have been true that an American was more likely to die in his bathtub than as the result of a terror attack, but people have some contrc over their bathtubs. They have control over their cars (another big source of annual deaths). Anc they use their cars and tubs every day without incident, whereas any encounter with a violent jihadist is bound to end badly. Terrorism by those attempting to destroy your way of life has a we of activating every primitive us-versus-them/fight-or-flight impulse in our brains. So even if the chance of any particular American becoming a victim of a gun-wielding jihadist shouting "Allahu Akbar!" was minimal, the smoldering ruins of the World Trade Center and the Pentagon were imprinted on our minds and shouted "Defense!"

One of the least savvy things Barack Obama ever did was to downplay the threat of terrorism. H called ISIS the "JV team" and urged Americans not to respond with fear to attacks in San Bernardino, California, and elsewhere. Attempting to talk people out of their fear of terrorism was futile, and arguably played into the hands of Donald Trump, who used the San Bernardino attack as the springboard for his vicious call for a ban on all Muslims entering the country.

Now it is Republicans who are attempting to talk people out of their fear. They're saying there's nothing we can do and that, actually, your kids are safer in school than in your living room and what about Newark? If Democrats were smart, they would seize upon this and be the party that takes your safety seriously.

And it's not dishonest. These mass shootings are a greater threat to our security than Islamic terrorism was. If a Fourth of July parade is not safe, nowhere is safe. America is a free-fire zone.

It is too damn easy to get powerful weapons. We don't need to repeal the Second Amendment (impossible anyway) to restrict the easy availability of powerful weapons. In the Highland Park case, just as in dozens of recent mass shootings, the young killer purchased his weapon legally. In the vast majority of these recent mass shootings, the killers just waltzed into gun stores and bought them. As my Bulwark colleagues have argued, we could raise the age to purchase a weapon to 25 . We could require extensive training on gun safety. We could limit magazine sizes We could restrict the sale of body armor. We could improve the background-check system (the Illinois creep passed his). In short, we could respond to the demoralizing fear that our country is so sick on the subject of guns and so divided that we cannot be safe in public. Not even on the Fourth of July.

Highland Park police records indicate a turbulent home life for the alleged parade gunman

Good morning, Chicago.
Highland Park police were called to the family home of the alleged Independence Day parade sniper at least nine times between 2010 and 2014 in response to domestic disputes, according to newly released police records.
Most of the incidents involved allegations of verbal or physical altercations between the shooting suspect's parents, Robert Crimo Jr. and Denise Pesina. The reports, released by the Highland Park Police Department, paint a picture of the sometimes tumultuous home where Robert "Bobby" Crimo III grew up before he allegedly shot dozens of people enjoying a Fourth of July parade.
A reporter saw a woman on the front porch at the home Thursday, but no one answered the door. Grass grew wild in the front lawn. Faux stained glass-style vinyl stickers decorated the windows, behind which white curtains were drawn. In the backyard, a haunting painting appeared on the faded reddish-brown brick: a tall figure holding a long rifle dressed in military camo with a yellow smiley face for a head.

## House Panel Asks Gunmakers To Testify Amid Mass Shootings

Reuters ${ }_{\sim}$ ( $7 / 7$, Shepardson, Heavey) reports the US House Oversight Committee has announced it is asking "the chief executives of three gunmakers to testify on July 20 as part of its investigation into the firearms industry following a wave of high-profile mass shootings." Specifically, the "panel called on the CEOs of Smith \& Wesson Brands...Sturm, Ruger \& Co...as well as privately held Daniel Defense to appear." In a letter to the executives, Committee Chairwoman Carolyn Maloney (D-NY) wrote, "I am deeply troubled that gun manufacturers continue to profit from the sale of weapons of war, including AR-15-style assault rifles. ... Products sold by your company have been used for decades to carry out homicides and even mass murders, yet your company has continued to market assault weapons to civilians."

## Illinois Red-Flag Law Could Have Stopped Highland Park Gunman

The AP $\forall$ accused of carrying out the mass shooting at Highland Park's Fourth of July parade - from buying a gun. The AP explains, "Police in the Chicago suburb of Highland Park were called twice to" Crimo's home in 2019 - "once after he tried to commit suicide and again when he allegedly threatened to 'kill everyone' in his family. On either occasion, they could have immediately exercised part of the law that allowed them to seek a restraining order to prevent Crimo from buying guns for anywhere from 14 days to six months." The AP adds, "Obtaining such a delay could have bought critical time for police to seek more information to ask a
judge for a longer order preventing a gun purchase." However, "Highland Park police did not seek such an order, and they were not required to do so."

## Texas Governor Orders National Guard, State Police To Take Migrants Back To Ports Of Entry

The New York Times 国 (7/7, Goodman) reports Texas Gov. Greg Abbott (R) on Thursday ordered the Texas National Guard and state police "to begin apprehending migrants who illegally cross the border from Mexico and taking them back to ports of entry, a move that could put the state into direct conflict with the federal government over immigration." Abbott said in a statement that the goal was to return "illegal immigrants to the border to stop this criminal enterprise endangering our communities." The order "came amid mounting pressure on Mr. Abbott from conservatives and Republicans to take even more drastic action to address the record number of arrivals from Mexico."

## Kenosha, Wisconsin Lawmakers Lift Ban On Guns In Government Buildings

The AP $\square(7 / 7)$ reports supervisors in Wisconsin's Kenosha County supervisors "have voted to oppose new gun restrictions and lift a ban on firearms in county buildings." The vote result comes not long "after the Highland Park parade shooting that left seven dead and dozens injured in neighboring Illinois and a July Fourth shooting in Kenosha that killed one person and injured four others." The Kensoha County "resolution lifts a 2011 ban on possession of firearms on county property except for law enforcement officers. The new policy excludes the county courthouse, jail and other law enforcement-related buildings. The board also voted to declare Kenosha County a Second Amendment sanctuary. The resolution said the board opposes any legislation that would 'infringe upon the Right of the People to keep and bear arms' and would consider those laws 'unconstitutional and beyond lawful legislative authority.'"

## US Lawmakers Push Administration To Protect US Border From Fentanyl Trafficking

Fox News (7/7, McKee) reports, "A bipartisan bill proposed Thursday would push the Biden administration to strengthen efforts to stop fentanyl from flowing into the US from the southern border, as overdose deaths continue to spike nationwide." Reps. Abigail Spanberger (D-VA) and Andrew Garbarino (R-NY) "introduced the Securing America's Borders Against Fentanyl Act, which would authorize $\$ 20$ million for research to target and detect fentanyl coming across the southern border and strengthen data-driven targeting to increase seizure rates. In April 2022, the US Drug Enforcement Administration announced a nationwide spike in fentanyl-related mass-overdose events, and fentanyl has become a key focus of the 2022 midterm elections as a community and a southern border issue."

## Draft Map Of New Baltimore Police Districts Seeks To Balance Law Enforcement Resources

The Baltimore Sun $\boldsymbol{T H}$ ( $7 / 7$, Skena, Opilo) reports, "The Baltimore Police Department released a new proposed map Thursday of its nine police districts that promises a significant redistribution of law enforcement resources and seeks to mend divisions in neighborhoods that currently are split between multiple districts." The Sun adds, "Officials presented the plan as a step toward making the department operate more efficiently despite a deepening staffing shortage. Harrison said the new districts would allocate police resources more equitably throughout the city, instead of having them concentrated in some areas more than others. The proposal brings the city another step closer to establishing new district boundaries - the first substantive change in over 60 years. The redistricting process, which began last year, was required under state legislation passed in 2019 that directs Baltimore Police to reevaluate district boundaries after each decennial census."

## Dallas, Texas Mayor Announces New Initiatives To Combat Crime

CBS News ( $7 / 7$, Fink) reports that this week, Dallas, Texas Mayor Eric Johnson "announced new public safety initiatives to keep violent crime down. 'The bottom line is when it comes to keeping our residents safe, we can never ever become complacent,' Johnson said." The new initiatives "are in addition to" Johnson's Task Force On Safe Communities strategies, "Dallas Police Chief Eddie Garcia's violent crime reduction plan and the Mayor's Summer of Safety Campaign designed to connect teenagers to low-cost programs and keep them out of trouble." Johnson "wants the city to become more aggressive
and go after property owners that cause public safety problems. The Mayor said he wants to work with the state to target problem bars before they become crime problems."

## Analysis: Illicit Fentanyl Driving Overdose Deaths Increase Trend In Oregon

The AP primary driver of an increasing drug overdose deaths trend in Oregon. According to the analysis, those fatalities "more than doubled between 2019 and 2021." The Oregon Health Authority's Dr. Dean Sidelinger warned that preliminary data indicates the trend has continued in 2022. Sidelinger stated, "We are seeing a critical need for naloxone as many communities experience dramatic increases in overdoses due to fentanyl misuse." Sidelinger added, "We encourage everyone in Oregon to educate themselves and their loved ones - including young people-about the importance of naloxone, how to use it in an overdose emergency, and where people can access it." Health officials also warned Oregon residents that they should assume any pill that has not been properly prescribed to them is counterfeit and may contain enough illicit fentanyl to cause a fatal overdose.

## Kentucky Opioid Crisis Response Study Expands

The Ashland (KY) Daily Independent (7/7, Chapin) reports, "The University of Kentucky's $\$ 87$ million HEALing Communities Study (HCS) to address" the opioid crisis in Kentucky is expanding. The Daily Independent adds, "The second wave of the study" was recently launched in "Bourbon, Campbell, Carter, Greenup, Jefferson, Jessamine, Knox and Mason counties."

In related coverage, Spectrum News (7/7, Forcade) reports Gabi Deaton, who is "the prevention specialist coordinator" for the University of Kentucky's HCS study, is "handing out free Narcan as part of the job." Deaton is also "making sure people know how to use" the opioid overdose reversal drug by presenting a weekly instruction session on Madison Avenue in Covington, Kentucky. Deaton said the sessions are held there because Madison Avenue is close to "multiple sober living houses. We seem to have a really good turnout every week."

USA Today $H_{-}(7 / 7)$ reports, "Young men in America always have been susceptible to violence," but pressures faced by such individuals have been "compounded by an intensifying mental health crisis that got exponentially worse during the pandemicforced isolation."

During each of the robberies in this case, "the suspect was wearing a black hat and face covering, a $T$-shirt and jeans. He is nicknamed the 'Spell Out Bandit' due to his comprehensive list of demands. He is wanted in the bank robbery at the UMB Bank located at 707 Colorado Boulevard on both June 15 and June 21; a bank robbery at the US Bank located at 730 Colorado Boulevard and an attempted bank robbery at the PNC Bank located at 777 S. Monaco St."

## Highland Park and an Illegitimate Supreme Court

Recent rulings on gun and abortion rights have revealed a conservative majority executing a long-standing agenda of radical right-wing ideas.

Certain ironies are too bitter to need articulating. They inspire a nonverbal response-one's head slumped and held in one's hands, as one shakes it in disbelief. So it is with the fatal shootings at an Independence Day parade in Highland Park, Illinois, on Monday, the latest in the long, unending line of gun massacres that increasingly decorate American life. This one, which featured a melodramatic neatness that would embarrass the maker of a "Batman" movie, involved the superimposition of seventy rounds of murderous gunfire and Fourth of July fireworks. At this point, Americans are permanently uncertain which sound is which. Once again, the elusive question of motive-this killer even, in another awful horror-movie note, disguised himself as a woman as he left his rooftop perch, to avoid detection-was less important than the trauma that will never leave the minds of the families or the observers. "I don't think the average person has to see a body eviscerated, or a head injury that's unspeakable, to understand that," a doctor who attended the parade and cared for the wounded said. "They shouldn't have to see that to understand what the problem is with this country."

The murderer had, predictably, a rapid-fire military-style weapon-of a kind banned in Highland Park, as they surely are for civilians in most parts of the world. But bans are of limited use in a country where guns are so widespread. The question
of whether this or that particular gun measure would have stopped this or that particular massacre is increasingly pointless to pursue. It is the totality of gun restrictions weighing on the availability of guns that reduces gun violence. The familiar screams of objections ("It wasn't an AR-15! It was an AK-47!") are a sorry sign of the fetishistic intensity of the crisis; no one needs to know exactly what make of gun it is to know that it's the kind of gun that should never be in the hands of anyone except soldiers. We stop gun violence by stopping guns, and arguing which gun is which is a way of avoiding the necessary solution. The solution is simple: every time we restrict access to instruments of mass killing, we insure the greater safety of our children. Every time we prevent someone from getting their hands on another gun, we are making the country safer. Gun control acts on gun violence as antibiotics act on infections, and as vaccines act on viruses: not infallibly and not every time, but over all with efficacy and tangible consequences.

The massacre comes on the heels of the Supreme Court's decision, on June 23rd, to make it impossible for New York State to enforce its commonsense measure against the "concealed carry" of handguns. The decision arrived, of course, the day before the Court's right-wing Justices overturned Roe v. Wade, after a half century. In the two decisions, the conservative Justices showed, of course, a complete lack of the type of minimal consistency that we identify with good-faith jurisprudence. In the first, they affirmed the Court's right to intervene in democratic decisions made by the States, in defense of a contested constitutional right; in the second, they affirmed the Court's complete inability to intervene in democratic decisions made by the States, even in the face of a long-settled constitutional right. In one decision, the desire of the people of New York not to have everyone conceal guns in their waistbands has no bearing on gun lovers' right to pack. In the other, the desire of the people of Mississippi to deprive women of the right to abort their pregnancies is just, well, the people's choice. A great American once wrote that consistency is the "hobgoblin of little minds," but for credible judges it's paramount.

One might deduce that perhaps what the conservatives on the Court want is not conservatism, nor the pursuit of any particular judicial philosophy, but the execution of a long-standing agenda of radical right-wing ideas. Various strenuous efforts have been made to reconcile the inconsistency-the notion, for instance, that the right to own any gun you like is a right found originally in the Constitution, whereas the right to privacy is a phantom right, only recently deduced from it.

The idea is ridiculous: both are as real and as phantom, it now seems, as the conservative majority chooses to make them. The right to individual ownership of
guns never existed in anything except the reveries of the N.R.A. until District of Columbia v. Heller, in 2008. Indeed, the Second Amendment decision was drawn against the plain sense of the Constitution's text, which after all includes the words "well regulated." The belief, on the other hand, that an overwhelming right to privacy is implicit throughout the Constitution isn't the least fantastical. That concept has long sat at the heart of democratic life. The idea of privacy is as vital to humankind as the idea of liberty, which it complements. It is the core of what it means to live as a free person in a free society. An overriding conception of privacy is at the heart of the right to contraception, or of the right to marry whom one chooses instead of those whom the State allows. And it is, of course, no accident that Clarence Thomas, in his vituperative opinion on the reversal of Roe, points directly at eliminating those other rights, as well.

The two decisions and their contradictions clearly undercut the credibility of the Court. One long legal study of the question insists legitimacy depends, in part, on the perception that "a Justice should apply her preferred approach consistently across cases, with candor and in good faith." No reasonable person reading the two decisions can believe they were made in good faith. It is obvious that they were made to suit a fixed political agenda, reasoned backward from the vengeful results. "How does the dissent account for the fact that one of the mass shootings near the top of its list took place in Buffalo? The New York law at issue in this case obviously did not stop that perpetrator," Alito wrote, in his concurring opinion on the gun case. It's the kind of argument one might expect from a YouTube commentator-""See, they still have knives in London!"-as though the fact that a law has been broken shows that a law can never work. By this standard, no law could ever accomplish anything.

Alito and Thomas and the rest were not engaged in a disinterested scrutiny of rights and rules. They were not acting in good faith, nor trying to find a consistent line of reasoning. A wiser Court with a more Solomonic temperament might have prudently sacrificed one decision for the other, in an effort to at least appear to be consistent. It might have decided not to issue both decisions in the same week. But it is plain from the tone and attitude of the Court's conservative majority that the only temperament it wanted to display was a regal one-the right to rule by whim. We do this because we can.

And so several normally moderate and sensible people-including the commentator Dahlia Lithwick-have not hesitated to call this court's legitimacy into question, and confidence in the Court is at an all-time low. Yet to speak of the

Court's loss of legitimacy, we're warned, is to risk joining with those who subvert democratic institutions or declare the 2020 election illegitimate.

There is a vast conceptual difference here, however, called basic fact. The truth is that, whereas the 2020 election was inarguably free and fair and democratic, the Supreme Court is - in a straightforward, empirical sense - no longer a representative institution reflecting, more or less, the will of the American people. Instead, thanks to the Electoral College and the Senate, two of the least representative bodies in the federal government, the Court is elevating a minority view to power through a series of undemocratic measures and actions. Three current Justices were appointed by Donald Trump, a man who lost the popular vote in 2016 and now stands exposed as an avowed enemy of the American constitutional order. That the conservative majority he created still demands absolute deference would likely strike the citizens of any other country as bizarre and irrational.

We speak of six, but in truth it's clear from his quaking dissents that Chief Justice John Roberts lives in fear of being the man on whose watch the Supreme Court loses its legitimacy. He knows perfectly well that the Court's legitimacy ought to be on the line when it makes radical, anti-democratic decisions, guided by religious fanaticism and sheer bloody-mindedness-that is, the will to get even with your opponents, even in the face of common sense and with people dying in the streets. Yet, although we have had indignation from the President, where has the intensity of passion gone in our politics? The passion felt by people like the Highland Park doctor, who saw the results of unending gun violence, seems drowned out by obsessive proceduralism. Pragmatism is a beautiful thing, but meaningless without principle.

One of the multiple crises of our time is the "crisis of no consequences." But the only way that John Roberts and the conservative majority will feel that the Court's legitimacy is on the line is if it is-if they fear the scale and scope of the reaction to their decisions. As people die in the streets in ever greater numbers, and as women's autonomy grows ever more curtailed, calling out the Court's legitimacy may be the only way to save it.

It seems very cowardly to me that these shooters kill unsuspecting people.

They are meant to bring you together in support of each other to discuss, reflect, and counsel.

Northern Illinois Critical Incident Stress Management (NI-CISM) will be on site Friday and Saturday from 2:00 PM 10:00 PM for drop-ins. They will be located in the first floor Police Training Room. We encourage all officers involved in Monday's incident and response to check in and meet with a peer resource as time allows. No advanced appointment is necessary.

Lake County Family Service will be holding group debriefing sessions in the Police first floor small conference room Friday at 9:00 AM and 11:00 AM for sworn and civilian staff wishing to debrief their experience in a group setting with counselor facilitation. No advance appointment is necessary. These sessions are open to all. An invitation has also been extended to our CERT members present for Monday's incident.

ATF Peer Responder Program is scheduled to be on-site next week for group sessions with peer facilitators experienced in crisis incident debriefing. Exact dates and times are TBD, but multiple sessions will be available. Sessions will take place in the first floor Police Training Room. I will send out more information once exact details are confirmed. All sworn officers involved in Monday's incident and response are highly encouraged to attend. Arrangements will be made during your scheduled shift to allow for attendance. Civilian PD staff are also invited to take part.

On a personal note, words cannot adequately express how proud we are of the service you've done for this community. If you have questions in regards to the listed resources or wish to seek other available resources through our employee assistance programs, please don't hesitate to reach out to Emily, Aaron, Dr. Plazas or myself.

This note is just to let you know that we are thinking of you in your duties for the City during this difficult time. I miss seeing you at Rotary events but know that you are dealing with many problems, probably not as difficult as responding to this shooting in our wonderful city, as well as supporting your family. Karla and I have a deep faith, and you should know that we are praying for you for strength and support. I can't think of anyone more capable of doing the work you do for the city.

An ocean cruise that was cancelled in 2020 because of the pandemic was rescheduled for 2022, and that is where we are now. It's a cruise that started in Bergen, Norway and is making its way around Scotland (where we are today), then Ireland, and finally scveral stops in England before a final stop in London. If we would have been home in Highland Park, we would certainly have talked with our son and his family about attending the $4^{\text {th }}$ of July parade. We have often sat near the location where the shooter chose. We
did catch yesterday's TV news cast where you were one of those supporting the police chief during a press conference.

It's deeply saddening to me that disturbed young men think a way to get attention is to shoot others in a public place. Polls indicate that a significant majority of Americans want their government to enact more stringent gun control, but politicians do little to make that happen. One candidate for governor seems quick to ignore the problem, as he suggested his followers "move on" after the recent shooting, rather than suggest doing something about it. It seems very cowardly to me that these shooters kill unsuspecting pcople.

Give an Hour is a national nonprofit providing mental health care since 2005 through a network of licensed and trained therapists. As Anita offered, we continue to work closely with the Ventura County community to provide responsive long-term support to survivors and loved ones of the Route 91 and Borderline events, provided 30+ therapists to help at a pop up clinic in the local library, and will be offering community supports, by request, in Tulsa.

We know that the community's needs will shift and change in the days, weeks, and years following July $4^{\text {th }}$ and we just want you to know we are here if you need us. Our work is generally long-term support for survivors and community members as well as customized supports for those working the front lines of these tragedies. In addition to our trauma trained therapists, we employ three mass gun violence survivors at present, all of whom inform our authenticity of service with and for those healing from these types of events.
