Horrific shooting incident on nation's celebration day in Highland Park, IL deeply shocked the whole community– the ripple effect of this horrific incident impacts many in different ways. For many individuals and families this event will remain a traumatic experience of their life for long time and the community will need some time to recover as well.

Over the next few days, the response, both operational and psychosocial, will transition from the immediate phase to providing a mid to long-term response, requiring comprehensive coordination, deliberate planning of emotional support provision to various circles of impact along the timeline, including identification of needs for these phases and availability of recourses.

In light of the reality described above, and based on our experience in supporting the psycho-social response to multiple incidents in Israel and around the world, the following steps are recommended:

- Identification, mapping and scoping of needs of different groups of people impacted by the incident in various intensity (families that lost their loved ones, survivors, parents/children of missing and dead, community institutions such as schools, first responders and care-providers etc.) including the projection of those needs' development along time, including various time marks (end of forensic procedures, funerals, back to school, holidays and so on).
- Identification, mapping and scoping of psycho-social support recourses (it should be kept in mind that such a transition also comes with withdrawal of "helping hands" that will be so useful during the first days and gradual decrease in availability of outside help. Also the initial response always characterized by certain level of duplications and deficits as one, due to the fact that multiple organizations are "jumping in" to help, not always in most coordinated way.
- Development of mid and long term, detailed and coordinated plan for prolonged psycho-social response, based on development of common language, utilizing all available community recourses (not only mental health professionals), progressing from short-term interventions, targeting acute trauma to full rehabilitation, focusing on It on strength and resilience of the community and its members.

From our perspective and experience, the recommended way to deal with these challenges is via a comprehensive systematic community approach that enables all the local agencies and stakeholders, formal and informal, to share their knowledge and resources and integrate their actions in favour of the community so that a continuum of care can be created in a shared language and culture of services.

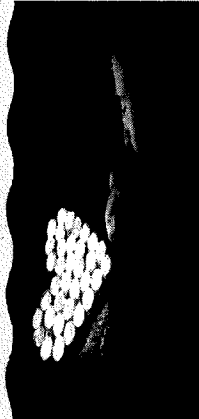

Stress reactions can include-

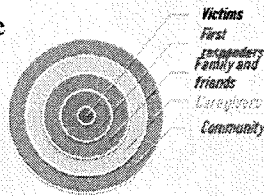
- Intrusive thoughts and images, nightmares or flashbacks of the event.
- Emotional and physical reactions to the event while awake or dreaming.
- Avoidance and withdrawal, feelings of detachment and estrangement, loss of appetite, depression.
- Physical arousal, irritability or outbursts of anger, difficulty falling or staying asleep.

Circles of Impact

In this kind of a crisis, there are various circles of impact, where the most vulnerable/affected persons are the ones most directly exposed.



Parents: how to recognize signs of distress in your child?

- Regressive behaviors such as: clinging, crying, bed-wetting, thumb-sucking.
- Aggressive behaviors such as: anger, risk-taking, impulsiveness.
- Avoidant behaviors such as: isolation.



Children usually react to the emotions of the adult around them. their reactions may vary in accordance to their age and stage of development

How to help children cope with grief and stress?

- Tell the truth about what happened.
- Be prepared for a variety of emotional responses.
- Be aware that your reactions and coping methods can be a model for your child.
- Help the child name their emotions and ensure them it's ok to feel this way.
- Be comfortable saying, "I don't know."
- Let the child grieve in his or her own way.
- Use relaxation techniques.

Where can I find support?

Reach out for professional help if...

- Symptoms of stress as a result of for help.
- The first 48 hours might be shocking, and any symptoms you may experience would be normal.
- If the symptoms last over a month following the event, please reach out to a professional for help.

- Physical arousal, irritability or outbursts of anger, difficulty falling or staying asleep.



Normal reactions to an abnormal situation

Circles of Impact

In this kind of a crisis, there are various circles of impact, where the most vulnerable/affected persons are the ones most directly exposed.



Parents: how to recognize signs of distress in your child?

- Regressive behaviors such as: clinging, crying, bed-wetting, thumb-sucking.
- Aggressive behaviors such as: anger, risk-taking, impulsiveness.
- Avoidant behaviors such as: isolation.



Children usually react to the emotions of the adult around them. their reactions may vary in accordance to their age and stage of development

How to help children cope with grief and stress?

- Tell the truth about what happened.
- Be prepared for a variety of emotional responses.
- Be aware that your reactions and coping methods can be a model for your child.
- Help the child name their emotions and ensure them it's ok to feel this way.
- Be comfortable saying, "I don't know."
- Let the child grieve in his or her own way.
- Use relaxation techniques.

Where can I find support?

Reach out for professional help if...

- Symptoms of stress as a result of for help.
- The first 48 hours might be shocking, and any symptoms you may experience would be normal.
- If the symptoms last over a month following the event, please reach out to a professional for help.

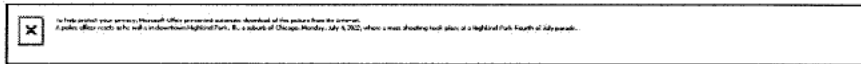

City left reeling after July 4th parade attack

Highland Park, Illinois, a suburban city north of Chicago, was left shaken and mourning after its Fourth of July parade was the site of yet another mass shooting. A seventh victim in the attack died Tuesday, Lake County Deputy Chief Christopher Covelli said. Five victims, all adults, were killed along the parade route Monday, and another victim died at a hospital, according to Lake County Coroner Jennifer Banek. "I'm furious because it does not have to be this way," Illinois Gov. J.B. Pritzker said at a news conference Monday. As the names of the victims emerge, [here's what we know about them](#).

What happened in Highland Park?

The man accused of the shooting planned the rooftop rampage for weeks and donned women's clothes to escape into the crowd, police said Tuesday.

A quick rundown:

- **Police say the suspect acted alone** and fired more than 70 shots before abandoning the assault rifle and walking to his mother's home.
- **Hours after the attack**, a neighbor saw the suspect driving and called 911, leading to his arrest. A second rifle was found in the car.
- **Investigators have interrogated the suspect** and reviewed his social media posts, but suggested no motive for the attack.
- **The gun used** – “similar to an AR-15” – was legally purchased by the suspect, police said.

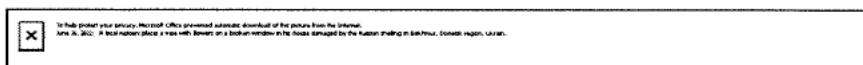

Until Moscow "asks for forgiveness, pays reparations to the state" and ensures "all its war criminals are in prison," Ukraine Prosecutor General Iryna Venediktova said she doesn't see how ordinary Ukrainians and Russians can achieve reconciliation after the war. "How is this generation (of Russians) ever going to look Ukrainians in the eye after all these actions?" asked Venediktova, the country's top legal official. "They behave like barbarians." How do I check the vertical datum system GNSS SP-85/Ranger 7 is using? We know that you set up the horizontal coordinate system using NAD83. Based on the recent benchmark verification shots recorded yesterday, it looks like the shots are close to NAVD88 which is compatible with our HP GIS system topography datum. And I am adding the known difference of 0.25 ft. (3 inches) to these shots to match the NGVD29 HP- Aero-Metric Engineering bench mark elevations. Originally I am getting big elevation discrepancies and I realized you set the Ranger 7 rod height to (2 meters) 6.56 usft. I reset it as when I measured the rod height to the base of the SP85 head mount, it is only 5.75 usft (69 inches).

Let us know the link to the delivered survey equipment (SP-85 and Ranger 7) recent user manuals.

Engineering is approving the package invoice that arrived this week. Let's set the date next week you are coming back for the 2 hr. outdoor training session?

In Case You Missed It: Nation Continues to Age as It Becomes More Diverse

The last two decades have seen the country grow continuously older. Since 2000, the national median age – the point at which one-half the population is older and one-half younger – has increased by 3.4 years, with the largest single-year gain of 0.3 years coming in 2021, bringing it to 38.8 years, according to newly released 2021 Population Estimates from the U.S. Census Bureau. Median age for most states also increased from 2020 to 2021, indicating their populations are getting older overall.

“The states with the lowest median ages saw the largest increases between 2020 to 2021. While Utah remained the youngest state in the nation, the state’s median age increased by 0.3 years from 31.5 to 31.8. Similarly, the District of Columbia had the second-lowest median age but saw the largest increase of 0.5 years from 34.4 to 34.9,” said Kristie Wilder, a demographer in the Census Bureau’s Population Division. “With birth rates trending downwards and the aging of the Baby Boom and Generation X cohorts, the median age will likely continue to rise in the coming years.”

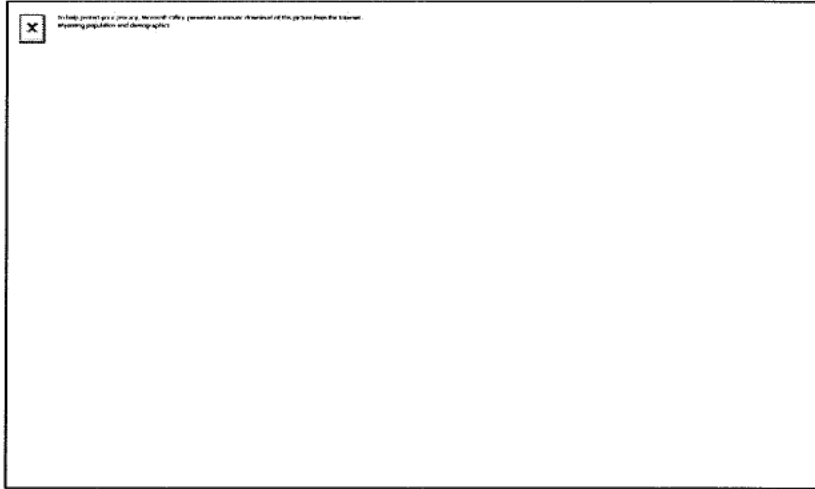

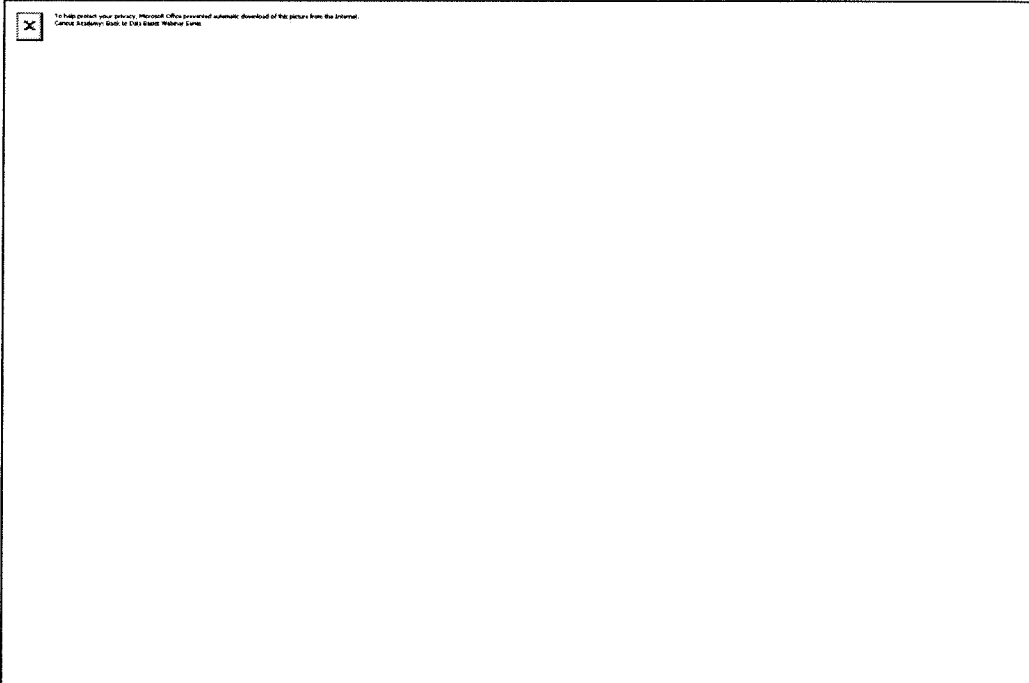

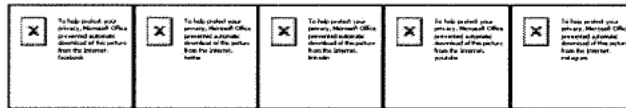

On 7/4/2022 at 1700 hours, Officer Fryc #141 and I responded to 3700 West Lake Avenue, ITW, for a Suspicious Vehicle.

Upon arrival, I spoke with complainant [REDACTED], security at ITW. He told me at about 1600 hours when he was doing his rounds in his vehicle around the property, a silver colored Honda Fit drive past him on the property at a high rate of speed. Gassman was unable to get a plate number and did not see the driver. Gassman searched the property but could not find the vehicle. He believed it may have exited the property onto Pfingsten Road.

After his rounds, Gassman watch the news about the shooting in Highland Park, IL. The news stated the suspect was in a silver Honda Fit. Gassman Google searched the make and model and believed it to be the same vehicle that came through the ITW property.

Officer Fryc and I searched the property and surrounding properties with no success in finding the vehicle.

NARRATIVE

On 7/4/2022 at 1700 hours, Officer Fryc #141 and I responded to 3700 West Lake Avenue, ITW, for a Suspicious Vehicle.

Upon arrival, I spoke with complainant [REDACTED], security at ITW. He told me at about 1600 hours when he was doing his rounds in his vehicle around the property, a silver colored Honda Fit drive past him on the property at a high rate of speed. Gassman was unable to get a plate number and did not see the driver. Gassman searched the property but could not find the vehicle. He believed it may have exited the property onto Pfingsten Road.

After his rounds, Gassman watch the news about the shooting in Highland Park, IL. The news stated the suspect was in a silver Honda Fit. Gassman Google searched the make and model and believed it to be the same vehicle that came through the ITW property.

Reflections on July 4th, 2022

Independence Day stirs up emotions in people such as patriotism, pride, and happy anticipation of spending time together with family and community. For Maxwell Street Klezmer Band, it has always meant rolling down the street on a flatbed truck playing

klezmer music—our way of adding the voice of America’s Jewish community to the festivities. For the past decade, we have played in two parades in succession: First, in Highland Park, Illinois, and then in Skokie, Illinois.

Horror is not one of the emotions that Independence Day should stir, but yesterday, that is exactly what occurred. As you might have seen and heard on the news, Maxwell Street Klezmer Band had just begun to roll down the streets of Highland Park playing klezmer music when an individual began shooting into the crowd several blocks ahead of us. As parade-watchers began to flee past the band in the opposite direction, we quickly realized that something was terribly wrong and found a way to get out of the parade lineup to safety.

The musicians and I are experiencing the same feelings that people across the US and around the world feel: Shock, grief, sorrow, and anger. In addition, though, we are also experiencing distress at seeing pictures and videos of our band on TV, newspapers, and on the internet in association with this tragedy.

Our hearts are with the families and friends of the seven people who perished, and the thirty people who were injured yesterday in this senseless act of violence. We would like to thank the hundreds of people who have checked in on us to make sure that we are OK. For that, we are deeply grateful.

Our hearts are with the families and friends of the seven people who perished, and the thirty people who were injured yesterday in this senseless act of violence. We would like to thank the hundreds of people who have checked in on us to make sure that we are OK. For that, we are deeply grateful.

Reflections on July 4th, 2022

Independence Day stirs up emotions in people such as patriotism, pride, and happy anticipation of spending time together with family and community. For Maxwell Street Klezmer Band, it has always meant rolling down the street on a flatbed truck playing klezmer music—our way of adding the voice of America’s Jewish community to the festivities. For the past decade, we have played in two parades in succession: First, in Highland Park, Illinois, and then in Skokie, Illinois.

Horror is not one of the emotions that Independence Day should stir, but yesterday, that is exactly what occurred. As you might have seen and heard on the news, Maxwell Street Klezmer Band had just begun to roll down the streets of Highland Park playing klezmer music when an individual began shooting into the crowd several blocks ahead of us. As parade-watchers began to flee past the band in the opposite direction, we quickly realized that something was terribly wrong and found a way to get out of the parade lineup to safety.

The musicians and I are experiencing the same feelings that people across the US and around the world feel: Shock, grief, sorrow, and anger. In addition, though, we are also experiencing distress at seeing pictures and videos of our band on TV, newspapers, and on the internet in association with this tragedy.

Our hearts are with the families and friends of the seven people who perished, and the thirty people who were injured yesterday in this senseless act of violence. We would like to thank the hundreds of people who have checked in on us to make sure that we are OK. For that, we are deeply grateful.

I wrote to you this morning and hope I am not being a nuisance! I just read the following in the news, which proves my point:

"In April 2019, an individual called police a week after learning of Crimo attempting suicide, authorities said. Police said the matter was handled by mental health professionals with no law enforcement.

In September 2019, a family member reported Crimo had a collection of knives and "was going to kill everyone," authorities said. Police responded to the incident and removed the weapons from Crimo's possession, police said. Highland Park police notified State Police of the incident but no further actions were taken."

This is a very serious loophole in our mental healthcare system. We need to fix it. Mental Illness does not magically disappear. It is a life-time disease that requires serious intervention. This young man should NEVER -repeat- NEVER have been allowed to get a gun or walk with the mentally healthy outside of a facility. He needed, needs, and will ALWAYS need, serious intervention.

What can we do to fix the mental healthcare system in our country and keep guns out of the wrong hands? It's long past time to fix it, but it's not too late.

Highland Park schools could start by instituting mental health screenings for all incoming junior high/high schools students.

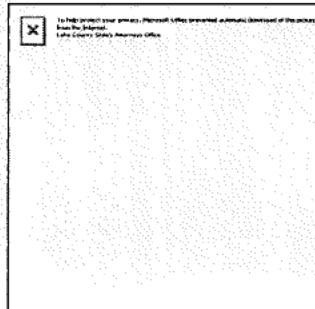

Murder Charges Brought Against Man Who Shot and Killed Seven, and Injured Many More

(Lake County, IL) Today, July 5, 2022, the Lake County State's Attorney's Office filed seven first-degree murder charges against 21-year-old, Robert E. Crimo III, for his pre-mediated and calculated attack at the Highland Park Parade yesterday. This is just the first of many charges our office will file against Crimo for the devastating killing spree he unleashed against our community.

Crimo was arrested Monday evening, in Lake Forest by the North Chicago Police Department after a brief chase and remains in custody. He is set to appear in bond court tomorrow morning, July 6, 2022.

"Our hearts go out to the seven families who lost loved ones yesterday. Dozens of people have already volunteered to support these families, and I know that Mayor Rotering, Chief Jogmen, Lake County, and our federal partners have already started the critical work of supporting these families who are most in need right now. Our office has also brought counselors to Highland Park today to assist in any way possible," State's Attorney Eric Rinehart said.

Approximately two dozen others were injured in the gunfire and have been transported to area hospitals.

"Our most urgent prayers go out to those who were injured and remain in the hospital. We know they are receiving the best medical care possible under difficult circumstances," Mr. Rinehart said.

The State's Attorney's Office is grateful to the courageous law enforcement officers who were there when gun shots were first fired and the numerous other law enforcement agencies from around Lake County and the State that responded to assist. Federal agencies including the FBI and ATF and US Attorney's Office have been critical partners in the investigation.

State's Attorney Rinehart stated, "Not only did police run towards the gunshots, help the wounded, and comfort families after heartbreaking news, but they also worked tirelessly throughout the day and into the night to investigate and solve the case. In just a matter of hours, they were able to identify and apprehend the suspect."

Tragedies like these remind us why it's important to have sensible gun laws and prevent people like Crimo from having access to firearms. If you have a family member or friend who is spiraling out of control towards violence, you must tell someone.

The investigation, which is being led by the Lake County Major Task Force, Highland Park Police, and FBI, continues. Anyone with information or those who have video footage should contact the FBI tip line at 1-800-CALL-FBI.

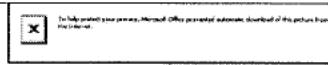

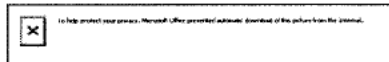

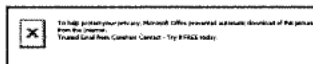
