Why? To reward the criminal by confirming he has achieved his goal of damaging us more than what was done on the $4^{\text {th }}$ to the victims and their families.

I recently returned from Israel. During our visit there was an unexpected renewal of terrorist attacks with many fatalities. The reason for this email is to share with you the advice given by the head of government to an ordinary citizen that asked what he can do and how should he react on a personal and family basis. His response was a lot healthier for the public than what is implied by closing the library.

So, what was the Prime Minister's instruction? It was to immediately return to your regular lives and not to change any plans or routines. He said "...we do not reward terrorists by giving them the satisfaction that they can destroy our spirit and optimism, we punish them."

The objective of the terrorists, like yesterday's tragedy, was to kill as many innocent people as possible and more. It was to inflict as much suffering as possible on the general population by making everyone feel unsafe and anxious about what's next and who is next. We are so blessed to live in Highland Park. Most of us have worked very hard to be able to live here. We are a disciplined community of people with strong values and a sense of personal responsibility. The criminal is responsible for what he did. But we are responsible to how we react.

I know your intentions are totally good - closing the library and cancelling activities is for one day is not such a big deal. Symbolically the implication is longer term and more significant.

## SCHNEIDER STATEMENT ON HIGHLAND PARK 4TH OF JULY SHOOTING

HIGHLAND PARK, III. - Congressman Brad Schneider (IL-10) released the following statement regarding the tragic shooting at the Highland Park 4th of July parade. Law enforcement has a suspect in custody.
"Yesterday, around 10:15 AM, a man on a rooftop with a "high powered rifle" shot more than 30 people at the Highland Park Independence Day Parade, murdering 7. What should have been a joyful celebration of our nation's birth ended in mayhem and tragedy. Our community has been rocked, families have been shattered, life will forever be changed.
"I extended my sincerest condolences to the families of those murdered, and am praying for the recovery of all those wounded or injured.
"I am grateful for the rapid response of the heroic first responders, as well as the many local residents who immediately stepped in to assist the wounded. I am thankful for law enforcement and first responders from communities in the area, the state of Illinois, and the federal government who urgently mobilized with remarkable professionalism to swiftly identify, locate, and apprehend the person of interest. I also appreciate the leadership of our Mayor Nancy Rotering, Police Chief Lou Jogmen, Fire Chief Joe Schrage, and countless others who shepherded us through the tense hours of yesterday. You all showed the power of community in the darkest of moments.
"Yesterday, our country experienced at least 4 mass shootings. We have suffered more than 300 mass shootings already this year alone (just 185 days). The nation needs to act, and act now, to save other communities from experiencing the pain Highland Park is suffering today. Most Americans agree on common-sense actions such as universal background checks and an assault weapons ban to keep our communities safe. Our community has my total commitment to do everything I can to make our children, town, and nation safer. Enough is enough.
"Highland Park is strong, and we will stand united as a community as we recover from this senseless tragedy. In time we will heal, but we will never forget. As the victims' names are identified, we will share further information with respect to their families' wishes. May the memory of the lives lost forever be a blessing.
"Free counseling is available to Highland Park students, families, and community members at the Highland Park High School. Please do not hesitate to go in person or contact (224) 765-2000 with questions or concerns."

Estoy agradecido a las fuerzas del orden y a los primeros intervinientes de las comunidades de la zona, del estado de lllinois y del gobierno federal, que se movilizaron con urgencia y con notable profesionalidad para identificar, localizar y detener rápidamente a la persona en cuestión. Nuestra comunidad tiene mi compromiso total de hacer todo lo posible para que nuestros niños, nuestra ciudad y nuestra nación estén más seguros. Ya es suficiente.
"La ciudad de Highland Park es fuerte, y nos mantendremos unidos como comunidad mientras nos recuperamos de esta tragedia inesperada. Con el tiempo sanaremos, pero nunca olvidaremos. A medida que se identifiquen los nombres de las víctimas, compartiremos más información respetando los deseos de sus familias. Quel la memoria de las vidas perdidas para siempre sea una bendición".

Police responded to a threat of a shooting at HP Hospital this evening, immediately before VP Harris arrived in town. A husband was with his wife in the ER and was upset at her treatment care and then threatened staff. He was charged with disorderly conduct.

We will not have a press briefing tomorrow; rather, we will issue communication with a focus on community care, crisis support and services. A morning update will be drafted and then released via all modalities.

I spoke to Jeff Haydon at Ravinia Festival this evening and they will be cancelling their performance through next Tuesday. Given that a portion of our business district is closed with limited access to parking, and given that our staff resources are directed toward the shooting investigation and community patrol, we have limited resources to be able to serve Ravinia Festival, particularly given the sold out Sheryl Crow concert. We will be reviewing Ravinia's statement before it is issued.

Good Day, My name is Jeffrey Winter. I am contacting you in regards to the recent shooting. If you are still struggling to find a motive I suggest that you look into whether the subject was taking any medications. Specifically, any Selective Serotonin Re-Uptake Inhibitors, or SSRI's. Every time I hear of a Mass Shooting or a suicide without a motive I can't help but think of what drug the person was on. Having attended the FDA hearing on the side effects of Anti-Depressants in 2004 in D. C, I met many families who had lost loved ones to suicide or homicide because of these medications. The stories were all very similar. The person had either recently started or recently changed their dosage of an antidepressant before they became suicidal/homicidal. There were also individuals who experienced these emotions and survived because they realized it was the drug causing them to think or act in this way. There was also a clinical study presented at the hearing that tested and proved the suicidal effects of the drug on teens and young adults. After that hearing, all SSRI's were given Black Box warnings on the suicidal effects of the drug on teens and young adults. No further studies were done to test whether the drugs had suicidal or homicidal effects in any other population. The pharmaceutical giants who produce these drugs continue to provide huge settlements out of court with gag orders while at the same time dismissing these cases to the medical community as anecdotal and refusing to perform clinical studies to see if there is a link to homicide or suicide in an older population. SSRI's continue to be one of the most prescribed medications in the country, with close to $13 \%$ of the population currently being treated.

Thank you for taking the time to read this and I hope to have provided some insight.

## Speaking with your children about the recent shootings

Because Facebook can handle longer posts, here's Dafna Lender's whole post about helping kids and teens in the wake of trauma

To parents of children who witnessed the shooting in the Highland Park parade, or to those who have friends and family who were victims or witnessed the shooting, my heart goes out to you.

Here are some things to consider to help your child:

First, be aware of your own behavior. Your behavior and general demeanor is the most impactful factor in how a child will process or experience the aftermath of the tragedy. Are you talking non-stop about the shooting with friends on the phone, in a heightened state of emotion, alternating between crying, watching news and worrying about the suspect? If you are distraught, it is best to have additional people in the house to help care for the children and dilute the intensity of your distress. It is important for the adults to rest in their own rooms and take breaks from processing the tragedy.

2-5 year olds: After the initial reactions of shock, disorientation or crying, young children may distract themselves with play or other regular activities, as though they are no longer affected. Or they may act spacey, hyperactive or irritable, but respond with indifference to the actual shooting. This is all normal. During this crisis, you should not be giving consequences to children for behaviors that you would normally not tolerate..mUnderstand that your child is terrified on the inside, and kids need you or a loving adult close by. Hold their hand, stroke their hair, put a hand on their back, sit knee to knee or shoulder to shoulder on the couch, give extra hugs and cuddles, read extra books, offer soothing drinks and extended bath-time.

6-10 year olds may be thinking of existential questions but do not know how to express them. So in addition to the above, you could start by saying, "When something so scary happens, our brains don't know how to handle it, so it starts asking some weird questions. You want to know some weird questions a brain might ask?" If they say yes, you could say "A brain might ask: "Is what happened my fault?" "Is there something wrong with me
that everyone else cares but I don't feel scared/sad/angry?' Is it ever safe to go to a parade (or to the beach or to the park) again?" If any of these questions resonates with your child, give an answer that is truthful, accurate and tailored to the child's developmental level. KEEP YOUR ANSWER SHORT. You should not try to sugarcoat the situation. Saying something like "I don't know but I will do everything in my power to keep you safe" is a good response. Then you might ask them what they think the answer is to their own question. This is how they will express their fears, so do not minimize it. Simply acknowledge that their answer is a possibility, and that you will get through this together.

Pre-teens and adolescents may have a confusing mix of reactions but they may be resistant to openly talking about them with us as their parents. We may want to pull them close, hug them and reassure them, but they might reject our overtures. Rest assured that your teens are thinking about the situation and that they are more sophisticated and nuanced in their understanding than you think. Invite them into a conversation as equals rather than coming in with an attitude that you are there to explain or protect them. For example, you might say "I was thinking about what I would have done if I had been right there, and I don't know what I would have done. Would I have known how to help?" If you were in the vicinity and in harm's way, you could say "It's so scary to feel the randomness of it all and I feel lost."

No matter the age, if your child is scared, crying, feeling panicky or reacts by having disturbed sleep or eating patterns, reassure them that this is a normal reaction. It's ike getting wounded when you break an arm or have a bad virus. Your body needs to repair. It needs time, TLC, reduced stress and pressure and time spent together with loved ones. A common reaction is to feel alternately "normal" and "not normal" (wanting to cry, hide, feeling anxious, etc). The important thing is to let the child know that it is their body's reaction, which is normal, and that as uncomfortable as it is, there is nothing wrong with their reaction and the time it takes to recover. During this period, which could be $2-5$ weeks, children should be allowed to follow their gut about whether they want to participate in previously scheduled events like camp or outings with friends. They may actually need to stay at home more, or to be with you, in order to reestablish a sense of safety.

For acute symptoms of anxiety, stress and panic, it is best to allow children to express their fears for a period of 5-7 minutes, more if the child is older, and then to offer "sensory resets", which are different experiences through our senses that re-orient the brain's focus on the anxiety to the novel feeling in our body. For example, drinking or eating something cold (ice popsicle), smelling something (give child hand or foot massage with fragrant lotion), movement (blow a balloon up and bop it back and forth), listening to music, reading a story, getting a change of temperature or air pressure by opening a window), going out in nature, digging in dirt, can all help settle the mind. All of these are activities that you can use for yourself as well.

If symptoms do not subside after six weeks, seek help from a licensed mental health professional who specializes in children and trauma.

And our patients can enter our offices directly from the garage without ever stepping foot onto the crime scene if the garage is not a part of the crime scene. And our business is not a store front. It is on the 3rd floor. We did close today. And I considered closing in general and for normal things that can wait but tomorrows procedures are emergencies and urgent. And I do not want to further burden our community right now by not being able to provide care.

I do potentially have the option of seeing our highland park patients in our Skokie location if the garage and garage access to 1770 first is to be closed.

First let me offer my condolences to Highland Park. Next, I want to volunteer with any backend support that I could do remotely, if it would of assistance. (Website, social media, HR, etc.). I could also come out for a week, on-site, and just stay a friends and then you could put me where you think you could use me. (1 just need to coordinate any on-site dates with my wife.)

I'm sure someone has already suggested this to you, but at the summer conference the Assistant Manager from the town of Wauskesha in WI, the one that had the car drive through their Christmas parade about 7 months ago, she spoke about lessons learned from their tragedic event that resulted in 6 deaths and 62 injured.

She shared that they didn't realize how fast things happen with the media spotlight, etc. Although she didn't write out what she learned, I'd be happy to contact her tomorrow and try to bullet point out what her thoughts. Maybe something could be helpful? (The one's a recall are below:)

1. They needed to designate a pickup location for the personal items, a few days later... and they learned they needed counselors there, as residents had stories and needed to talk more then just collect chairs, wagons, blankets, etc.
2. That a location was needed for a temporary memorial. So flowers and other items could be dropped off and help the community grieve.
3. They had the town turn all of their lights blue 1 week later and businesses passed out free light bulbs. Helped withcommunity unity.
4. They had a few non-profits setup donation accounts for the victims families expenses (funeral, etc). As well as for the injured survivors, for medical expenses.

Well, I just saw that you have the VP coming tomorrow. So I'm sure you and your staff are working 24/7. Please just let me know if I could be of any help. And the offer is open, so get past tomorrow and then next day, and the one after that.

## Other Challenges:

On-going support for medical teams: From the very outset of the COVID-19 pandemic, many medical teams have worked extremely long hours in high-pressure environments. This pandemic has demanded extraordinary physical and mental effort from these healthcare workers. ITC is working with teams who require specialized attention to their wellbeing, tools to cope with the psychosocial pressure, to sustain and strengthen their resilience and to learn coping skills for themselves and their patients.

Emergency preparedness: The country is at a critical juncture and needs to be ready at any given moment to fight on multiple fronts including a terror war in Gaza and the West Bank, a conventional war on the Syrian/Lebanon borders and an armed uprising throughout the country. In any of these scenarios, natural disasters, terror or war there is also a possibility of mass evacuation of the populace from border regions. The new reality is that each Local Council Authority and community will be responsible for its own emergency preparedness and response. ITC is working with communities on the frontline to build their emergency preparedness and response capacity.

On-going support for medical teams: From the very outset of the COVID-19 pandemic, many medical teams have worked extremely long hours in high-pressure environments. This pandemic has demanded extraordinary physical and mental effort from these healthcare workers. ITC is working with teams who require specialized attention to their wellbeing, tools to cope with the psychosocial pressure, to sustain and strengthen their resilience and to learn coping skills for themselves and their patients.

Emergency preparedness: The country is at a critical juncture and needs to be ready at any given moment to fight on multiple fronts including a terror war in Gaza and the West Bank, a conventional war on the Syrian/Lebanon borders and an armed uprising throughout the country. In any of these scenarios, natural disasters, terror or war there is also a possibility of mass evacuation of the populace from border regions. The new reality is that each Local Council Authority and community will be responsible for its own emergency preparedness and response. ITC is working with communities on the frontline to build their emergency preparedness and response capacity.

## Achievements

- ITC's 12 Resilience Centers have become the central address for immediate, pro-active intervention, training and real time relief. Each Resilience Center ( 5 Southern centers, 4 Judea and Samaria, Ashkelon, Netivot and Bedouin Resilience Center) prepares customized emergency preparedness programs for local communities based on their needs, population and culture, creates a continuum of care including providing trauma-focused psychological treatment and builds community resilience by developing cohesion, teaching coping skills and forming volunteer emergency response teams.
- ADEPT Academy for Domestic Emergency Preparedness and Training (ADEPT) a partnership with Home Front Command. The Academy provides municipal community leaders and institutions with the tools required to aid their communities in preventing, protecting, responding to, and recovering from both manmade and natural disasters.
- International efforts Israel's experience preparing for and coping with crisis and terror makes Israeli trauma experts amongst the most knowledgeable on the global map. Our international work relies on experience and concepts developed over many years in emergency preparedness and trauma care in Israel. Teams of ITC experts share their knowledge and help local professionals establish recovery and rehabilitation programs in response to both manmade and natural disasters. ITC trains local care providers leaving behind a more robust civilian resilience network.
- N.Y following 9/11, Beslan 2004 terror attack in school, Mississippi 2005 Hurricane, Sri Lanka 2005 Tsunami, War in Chechnya 2006, Haiti 2010 earthquake, Japan 2012 earthquake, the Philippines 2013 Typhoon Yolanda, Boston 2013 terrorist attack, Ukraine 2014 and on-going civil war, Jordan 2015 Syrian refugees, France 2015 terror attacks, Nepal 2015 earthquake, work with Disaster Coalition in the Bronx, Ecuador, earthquake 2016, Mexico earthquake 2017, Las Vegas mass shooting 2017, Pittsburg synagogue shooting 2018, and Miami school shooting 2018.
Our partners over the years have included WHO, UNICEF, EU, Council of Europe, and Pompidou Group among others.
- U.N Recognition 2019 Israel Trauma Coalition (ITC) was recognized as an advisory body to the Economic and Social Council (ECOSOC) of the United Nations. In a unanimous decision the UN Committee on Non-Governmental Organizations (NGOs), conferred on ITC the highest status a non-governmental organization can achieve at the global level.
